AN ORDINANCE ADOPTING THE SIBUGAY BIO-DIVERSITY STRATEGY AND ACTION PLAN FOR THE YEAR 2023-2028 AND PROVIDING NECESSARY SUPPORT FUNDS FOR THE PURPOSE.

BE ENACTED, by the 8<sup>TH</sup> SANGGUNIANG PANLALAWIGAN of the PROVINCE OF ZAMBOANGA SIBUGAY, in session duly assembled, and

### ORDAINED THAT:

**Section 1. Title** – This ordinance shall be known and thereafter referred to as "AN ORDINANCE ADOPTING THE SIBUGAY BIO-DIVERSITY STRATEGY AND ACTION PLAN FOR THE YEAR 2023-2028 AND PROVIDING NECESSARY SUPPORT FUNDS FOR THE PURPOSE".

**Section 2. Adoption of the Sibugay Biodiversity Strategy and Action for the Year 2023-2028** – The Zamboanga Sibugay Biodiversity Strategy and Action Plan, copy of which is hereto attached as Annex "A", is hereby officially adopted and to be implemented for the Year 2023 – 2028.

**Section 3. Coverage** – The 2023 -2028 Sibugay Biodiversity Strategy and Action Plan shall cover the following;

1. Brief profile of Zamboanga Sibugay;
2. Protected areas;
3. Buug National Biotic Areas (BNBA);
4. Dumanquillas Bay Protected Landscape and Seascape (BDPLS);
5. Naga – Kabasalan Protected Landscape;
6. Local conversation Areas and other Important Habitats;

**Section 5. Repealing Clause.** All ordinances and resolutions, laws of local application and effect, or inconsistent hereto are hereby modified, superseded and repealed accordingly.


