Subject.— Right of way—Nilgiris-Coonoor Taluk—Longwood R.F. over the Kotagiri—Kerkambal road—admitted.

Proceedings.—

Under section 18 of the Madras Forest Act (V of 1882 a right of way open to people, cattle and vehicles as illustrated in the sketch attached and as described in detail below is admitted to a width of 10 yds. over the Kotagiri Kerkambal Panchayat Board road within Longwood Res. Forest (constituted as a Res. Forest" in Revenue Department Notification No. 119 dated 22nd April 1885, published at pages 289-290 of Part I of the Fort St. George Gazette dated the 28th April 1885 in Coonoor Taluk, the Nilgiris Dist.

2. The road authority for the time being is permitted to do all acts necessary for the maintenance of the road to a distance of 33 feet on either side from the centre of the road.

3. No right is conferred to any form of Forest produce and before any tree growth is cut, the fact should be reported to the Forest authority whose business it will be to take charge of it and effect its disposal.

Public right of way .. (5)

It enters the reserve on its western boundary at a point on a bearing of 163° and 27 links from the cairn at the trijunction of S.Nos. C.19, C 225 and C 18 A and runs generally east and north-east with the following bearings and distances and leaves the reserve on its western boundary at a point on a bearing of 230½° and 89 links from the first survey stone lying south-east of the trijunction of S.Nos. C 206, C 19 and C 18-A.

Record of rights

The two private holdings (C-12 and C-13) fall within the boundary, but are not included in the reserve. Existing rights in the following cases are admitted —
 (1) Conditional permission granted to Mr. F. Sherman for diversion of the stream known as Longwood stream from a point in Longwood shola by means of a channel running for about 300 yards through Government waste land till it enters Mr. Sherman's property called Charville.
 (2) The use of the new Kodanad road by the public, which passes through C-209.
 (3) The use of the Longwood bridle-path, which passes from the old Kodanad road through C-18, C-207 and C-208 to the new Kodanad road.
 (4) The use of the bridle-path which passes through the Neton estate (C-24) through the reserve (C-16) to the Longwood bridle-path above named.
