ORDER:

In the Government Order first read above orders were issued declaring the intention of the Government to constitute the Vettankudi-Karaivetti Lake, Ariyalur Taluk, Perambalur District as a Birds Sanctuary over an area of 280.16 hectares and a notification was issued for publication in the Tamil Nadu Government Gazette and District Gazette under Section 18(1) of the Wildlife (Protection) Act 1972.

2. The Chief Wildlife Warden, Chennai-15 has now reported that the Collector, Perambalur while performing his duties under section 19 to 25 of the Wildlife (Protection) Act 1972 has issued proclamation under section 21 for the above bird sanctuary over an area of 453.17 hectare by including the entire water spread area of Vettankudi Eri over an extent of 401.17 hectares and other Eris such as Pudu Eri and Nadu Eri and some patta lands in Ayan Suthumalli over 11.34.5 hectares and sent revised notification proposals under section 18(1) of the Wildlife (Protection) Act 1972 for approval.

3. In super session of the earlier notification issued in the G.O.first read above, the State Government desire that the areas defined in the schedule of the Notification appended to this order by reason of their ecological, fauna, flora, geomorphological and zoological associations and importance need to be constituted as a sanctuary for the purpose of protection, propagation and development of wildlife and its environment.

4. The Notification shall be published both in English and in Tamil in the Tamil Nadu Government Gazette and in Tamil in the District Gazette of Perambalur District.

5. The Tamil Development and Culture Department is requested to send immediately a Tamil Translation of the Notification to the Works Manager, Government Central Press, Chennai-79 for publication in the Tamil Nadu Government Gazette and in the District Gazette of Perambalur District.

6. The Works Manager, Government Central Press, Chennai is requested to send twenty copies of each (in English and in Tamil) of the notification to the Principal Chief Conservator of Forests/Chief Wildlife Warden/Government/the Collector of Perambalur District as soon as the Notification is published.

APPENDIX

NOTIFICATION

WHEREAS the Government of Tamil Nadu considers that the Vettakudi Eri in Karaivetti, Pudu Eri and Naḍu Eri and some patta lands in Ayan Suthamalli and Venganur Village in Perambalur District described in the Schedule below is of adequate ecological, faunal, floral, geomorphological natural and ecological significance for the purpose of protecting, propagating and developing the wildlife and its environment.

NOW, THEREFORE, in exercise of the powers conferred by sub-section (1) of section 18 of the Wildlife (Protection) Act, 1972 (Central Act 53 of 1972) and in supersession of the Environment and Forests Department Notification No.II (2) EF/1395/97 published at pp.422-423 in Part II-Section 2 of the Tamil Nadu Government Gazette, dated the 2ne July 1977, the Governor of Tamil Nadu, hereby declares her intention to constitute the area specified in the Schedule below as the Karaivetti Birds Sanctuary.

Boundaries

North:

The Boundaries of 65 Ayan Suthamalli Village starting from trijunction point of S.F.No.187,177,153 and 188. The boundary runs generally towards the West to East. The north side S.F.No.188, 189, 192, 193, 195, 208, 210/2B, 3A1 & 4B, 274/1 & 3, 275/1A & 2, 276/1 & 3, 295, 235, 236, 237, 245.

Earth:

Thence the boundary runs generally towards the souther side and starting from trijunction point of 65 Ayar Suthamalli Village S.F.No.277, 295, 287, and 288. After that the boundary runs towards southern side from North to Southside, the eastern side S.F.No.287, 286, 284/4A, 4C & 5, 282/2A, 3B, 4B, 5B, 6, 7B & 8B.

Starting from Karaivetti village 42/1C, 2B, 4B, 41/2A, 2B, 2C, 35/sB1A, 2B2, 2B3A, 2B3B, 2B3C, 2B3D, 36/1B2A, B2B, 1B2C, 1B2D, 1B2E, 1B2E, 1B2E, 1B2G, 1B2H, 1B2I, 1B2J, 1B2K, 1B2L, B2M, 1B2N, 37/2B, 38 and 53.

South:

Thence the boundary runs generally towards east to west and starting from trijunction point of Karaivetti village S.F.No.53, 54, 55 & 56.

Starting from S.F.No.55, 59, 57/1B1, 7B2, 8B1, 4B1, 4B2, 4B3, 66/1B2 A A, 73/4B, 5B1, 5B2, 3B, 21, 7A3, 7B, 7A2, 79/4B, 2B, 3B, 3B2, 4B, 5B, 80/2B, 8B, 8C, 83/6B, 84, 96/B1, 97/98/, 6B2, 6A2, 125/2, 126/B1, 2B, 127/1B1, 1B2, 1B3, 1B4, 1B5, 5B & 6.

122/5B & 6B1 and then runs towards Venganur village S.F.No.91/1B1, 1B2A, 2B, 5B, 6B, 7B, 9B & 10B, 88/10B, 11 B1A and 11 B1B

West:

Thence the boundary runs generally towards south to North and starting from junction point of 71 Venganar villages S.F.No.11B/1A, 1B.

After that the boundary runs towards western side S.F.No. 88/1A, 4A4, 4A5, 4A6, 8A & 11B/1A, 89/1A, 4A, 5A & 6A, 86/9A, 82/1A2, 2A, 6A & 83 & 77 and then runs to Karaivetti village boundaries

S.F.No. 189, 190 & 191 of Sannavoor village

And then returns to Eastern side boundary runs towards Eastern side S.F.No.235, 236, 237 & 245 and then to turns to Northern side boundary runs towards North in 65 Ayan Suthamalli village S.F.No.245, 243, 242, 220, 219, 218, 217 Part and 177
