ODENDAAL, Administrateur van die Provinsie Transvaal.</p>				<p>No. 14 (Administrator's), 1965.]</p> <p style="text-align: center;"><b>PROCLAMATION</b></p> <p style="text-align: center;">BY THE HONOURABLE THE ADMINISTRATOR OF THE PROVINCE OF TRANSVAAL.</p> <p>Whereas it is provided in paragraph (d) of section eleven of the Game Ordinance, 1949 (Ordinance No. 23 of 1949), that the Administrator may, from time to time, after reference to the Fauna and Flora Advisory Board, by proclamation in the <i>Gazette</i>, declare any area defined in such proclamation to be a Game Reserve until it is deproclaimed;</p> <p>And whereas it is provided in sub-section (2) of section two of the Native Flora Protection Ordinance, 1940 (Ordinance No. 9 of 1940), that the Administrator may from time to time by proclamation in the <i>Provincial Gazette of the Province of Transvaal</i>, established one or more native flora reserves or cancel any such reserve, with effect from a stipulated date;</p> <p>Now, therefore, under and by virtue of the aforesaid powers, after reference to the said board, I do hereby declare that each of the areas defined in Schedules I and III hereto shall from the 27th January, 1965, be both a game reserve and a native flora reserve to which the provisions of the said Ordinance will apply; and for general information it is hereby made known that I have assigned to each reserve the name indicated in the said Schedules I and III hereto.</p> <p>Given under my Hand at Pretoria on this Twenty-seventh day of October, One thousand Nine hundred and Sixty-four.</p> <p style="text-align: right;">F.
