

**WHEREAS**, the plan contains all the components provided in Section 17 of this Act and the timetable for the implementation of the solid waste management program is in accordance with the National Framework and pursuant to the provisions of this Act “The Ecological Solid Waste Management Act of 2000, its Implementing Rules and Regulations (DENR Administrative Order No. 2001-34)” and the Annotated Outline provided by the National Solid Waste Management Commission-Secretariat wherein it guide with a clearer and more comprehensive view on how solid waste should be managed and how the existing waste management problems of LGU-Del Carmen should be addressed.


