The least spoiled dune area of the Netherlands located between Oostvoorne and Haringvliet. The area includes two lakes (Breedewater, Quackjeswater) and mesotrophic dune slacks surrounded by Alnus woodland and wet dune valleys.

## 12. Justification of the criteria selected under point 9, on previous page.

Criterion 1: This dune area includes fine examples of wet dune slacks and freshwater lakes which are rare in Western Europe.

Criterion 2: The site has a high diversity of interesting plants and animal species including:

- one species of stoneworts Characeae of the national red list: *Chara contraria*;
- three species of mushrooms of the national red list including: *Gyrodon lividus* and *Arrhenia lobata*;
- six wetland mosses of the national red list including: *Bryum neodamense*; *Drepanocladus sendtneri* and *Preissia quadrata*;
- nine wetland plant species of the national red list including Fen Orchid *Liparis loeselii*; Grass-of-Parnassus *Parnassia palustris*; Parsley Water-dropwort *Oenanthe lachenalii*;
- one species of amphibians on Annex II of the EU Habitats Directive: Crested Newt *Triturus cristatus*;
- three species of birds included on Annex I of the EU Birds Directive: Great Egret *Egretta alba* [*Casmerodus albus*], Eurasian Spoonbill *Platalea leucorodia*, Osprey *Pandion haliaetus*.

The site is of natural origin, although people always have influenced the development of the site.

The two dune lakes Quackjeswater and Breede Water are sometimes completely dry, or the water surface level is low.

**15. Hydrological values:** (groundwater recharge, flood control, sediment trapping, shoreline stabilisation etc)

The dune area of Voornes Duin forms the natural coastal defence of the former island "Voorne-Putten" against the North Sea. Unlike most other dune areas this site is not being used for the extraction of drinking water.

Coastal freshwater lakes 4%, Coastal sand dunes 96%.
