

The boundary is the same as for Dunøyane Nature Reserve established July 1th 1973.

The site is composed of three separate islands and a large number of islets and small skerries. Sea areas in a distance of 300 m from all islands and skerries at lowest tide are enclosed in the site.

Dunøyane is located off the west coast of the southern part of Spitsbergen, approximately 150 km southwest of Longyearbyen, which is the administration centre of Svalbard. Longyearbyen has approx. 2000 inhabitants (2008).

14. Justification for the application of each Criterion listed in 13 above:

Criterion 1: This is a small marine archipelago with shallow waters with numerous skerries and some small islands. It is a typical archipelago for the biogeographic region.

Criterion 2: Polar bear Ursus maritimus (VU) are known to visit these islands to prey upon eggs.

Criterion 3: This group of islands and skerries are traditional and important breeding sites for Barnacle Geese *Branta leucopsis*, Pink-footed Goose *Anser brachyrhynchus*, Common Eider *Somateria mollissima* (783 pair in 1995) and Glacous Gull *Larus hyperboreus* (495 pair in 1995), characteristic species for this kind of archipelago in the biogeopgraphic region.

Criterion 4. This group of islands and skerries provide breeding sites for birds: see justification of criterion 3 and point 22.

Criterion 6: The site supports more than 1% of the individuals in a population of the following species: Barnacle Goose *Branta leucopsis* (454 nest was reported used in 1995 and 792 nests in 1992, usually 450-600 pairs breeds here; Svalbard population) and Common Eider *Somateria molissima*, usually 500-700 pairs. In 1995 there were registered 783 pairs (Svalbard, Franz Joseph population).

16. Physical features of the site:

Natural erosion processes occur on sandy shores and hard rock shoreline due to a very harsh climate with waves and sea ice. All fresh water on the islands originates from precipitation.

The archipelago mainly consists of dolomite, with some smaller areas of phylittes and conglomerates, all of Precambrian age.

The surrounding sea areas are shallow and nutrient rich. The shoreline around the islands consists partly of cliffs, partly of sandy shores. The land areas consist of bare rock and some areas covered with marine deposits. The tree islands are grass covered with small ponds. Middle tidal amplitude is approx. 1,5 m (Longyearbyen harbour). The climate is characterised by low temperatures and low precipitation. Average temperature in July is 4,0 °C. Annual average temperature is -5,4°. Annual average precipitation is 405 mm. (Hornsund – www.met.no). Drift ice occurs in winter and spring, but the archipelago is normally not icebound.

Shallow marine waters mostly less than six metres deep at low tide, includes sea bays and straits. Some deeper areas.

Situated in the Arctic and characterized by:

- archipelago in the coastal zone with rock or sand/gravel dominated shores.
- sparse grass vegetation and some small ponds. All vegetation on the islands is influenced by saltwater.
- drift ice occur in winter and spring, but the archipelago is normally not icebound.

Vegetation and vegetation types have not been surveyed and mapped, so no specific information is available.

Polar bear Ursus maritimus (VU) are known to visit these islands to prey upon eggs.

Birds:

On the national red list (Svalbard) or interesting species:

Barnacle Geese Branta leucopsis (450-600 pairs, 454 pair in 1995), Grey Phalarope Phalaropus fulicarius (NT) (101 ind. in 1995), Glaucous Gull Larus hyperboreus (>100 pairs, 495 ind registered in 1995) and Redthroated Diver Gavia stellata (10-20 pairs, approx. 20 pair reported in 1995) annually breed at Dunøyane. Nationally common species: Common Eider Somateria molissima (500-700 pairs, 783 pair registered in 1995), Arctic Tern Sterna paradisaea (>200 pairs), Great Skua Stercorarius skua (>20 pairs), Great Blackbacked Gull Larus marinus (1-5 pairs), Purple Sandpiper Calidris maritima and Arctic Skua Stercorarius parasiticus also breed here annually.

23. Social and cultural values:

Harvest of eggs and eider down has been performed with various intensity in Svalbard from the 18th century and until today. Trappers using this part of Spitsbergen as hunting grounds have also collected eggs and eider down also in this archipelago in the past, this collecting is not practiced in the nature reserve today.

Trappers living on the west coast of Spitsbergen have occasionally been given permission to collect eider down after nesting birds have left the islands.

b) in the surroundings/catchment: No human activity except for ships passing.

26. Factors (past, present or potential) adversely affecting the site's ecological character, including changes in land (including water) use and development projects:

a) within the Ramsar site:

No such factors are known.

b) in the surrounding area: Increasing tourism, oil spill from ships and oil/gas development projects in this part of the Arctic is a possible threat.

27. Conservation measures taken:

a) List national and/or international category and legal status of protected areas, including boundary relationships with the Ramsar site:

In particular, if the site is partly or wholly a World Heritage Site and/or a UNESCO Biosphere Reserve, please give the names of the site under these designations.

The Ramsar site was established as a nature reserve area July 1th 1973. The boundaries for the Ramsar site are the same as for the Dunøyane nature reserve.

The nature reserve lies within South Spitsbergen National Park (established in 1973) where hunting of all birds and mammals are permanently prohibited.

Some research and biodiversity monitoring have been conducted in the area. There is no field research stations in the area.

e.g. visitors' centre, observation hides and nature trails, information booklets, facilities for school visits, etc. No such activities have been conducted, mainly because of the remoteness of the area and difficult access.
